ARTICLES OF INCORPORATION

These Articles of Incorporation are signed and acknowledged by the incorporators for the purpose of forming a non-profit corporation under the provisions of Act No. 327 of the Public Acts of 1931, as amended, as follows:

ARTICLE I.

This corporation is not organized for the pecuniary profit of its trustees, officers, or members; no part of its net income shall inure to the benefit of any officer, trustee, or member; and any balance or money or assets remaining after the full payment of corporate obligations of all and any kinds shall be devoted solely to the charitable, informative, educational or benevolent purposes of the corporation.
