April 25th, the good news arrived: the proposal to print the EXPLORER series for exhibition at our Latvian embassy (and later in Latvia) received full funding from the Latvian Foundation. I am positive you are as delighted as I am.

The LF funds come from working Latvians who are willing to share the fruits of their labor to sustain the 'greater good'. The competition was stiff - 57 proposals, with only four proposals funded. To say that I am deeply honored is an understatement. Let us, in turn, make the foundation's vote of confidence count - by enthusiastically cooperating on hosting a successful and unusual event.

As we conclude the arrangements for the EXPLORER/MEKLETAJS exhibit - here is a brief review of our discussions to date: I began my dialogue with Ms Seng in October 2009; later I was directed to correspond with Ms Kine; and now Ms Eglite is apparently handling the arrangements.

In my last correspondence with Ms Kine, almost two months ago (March 18), I had asked for a final affirmation of the specific date for exhibit opening and times. That request appears to have been lost in the netherworld of electronic communications - perhaps a casualty of responsibility for the exhibitions area changing from one person to the next.

Perhaps this was to our advantage...as Ms Eglite pointed out in her April 26th e-mail to me, the weekend of June 5th - the alternative date I had proposed mid-March, when the tentative May date was nixed - is the very same weekend as the world-renown Riga

Doma Boy's Choir is appearing in Washington DC.

It would be slightly absurd to be opening an exhibit at the very same time, don't you agree? I myself might very well choose to go and hear the sublime angelic voices of the choir, rather than mill around an exhibit.

The EXPLORER exhibit is intended as an event to bring together the Latvian Washingtonian community in a ritual affirmation of our ties to a sacred land and a sacred heritage. June 5th, this very same community will be busy hosting our young ones. In other words - the June opening can no longer be considered practical.

Let's look at opening the exhibit the second weekend of September - on the 11th (birthday of Janis Rainis)? Refreshed from their Labor Day weekends and summer vacations, people will be ready to kick off the autumn cultural season. The EXPLORER exhibit would also be a nice way to lead up to our very crucial elections in October. It could stay up throughout election-day to inspire the voters - no?

This would give us four months to iron out any issues - with plenty of time for promoting the event. Although making the rest of the arrangements is fairly simple & straightforward, Helena Viksnins has agreed to be our 'man-on-the-ground' in DC, so if there are any questions or issues that require *her* assistance - feel free to turn to Ms Viksnins.

Congratulations on a fine line-up of presentations for the Latvian Embassy's open house May 7-8 ! In some form it resembles what Ms Seng, Ms Viksnina and I had envisioned back in October when we tentatively planned on opening the EXPLORER exhibit during the May Embassy Row open-house.

It does my heart good to see the beauty of Latvia recognized and recorded by someone as obviously accomplished and internationally well versed as photographer Matthew Blong.

Allow me to make a suggestion:

to expedite matters and to make the planning stages of the EXPLORER event run smoothly - from here on in, would it be possible to follow the same procedures as you used to arrange the photo exhibit with Mr. Blong?

I have two requests:

1. It would be helpful to have the same contact person on your end to ensure that we enjoy efficiency of process, and
2. A firm agreement on dates and times - communicated to me as soon as possible.

On your part, this is really all the work that has to be done at this point.

On my end, as soon as the monies are released by the Latvian Foundation, the printing of the exhibit will be initiated. The foundation

will receive the requisite accounting of fund expenditures as soon as the printing has concluded.

In closing, I again thank Ambassador Pildagovics for his solid support, and kudos to all of you for continuing to work in the better interests of our nation and people in these treacherous times.
