ARTICLES OF INCORPORATION

These Articles of Incorporation are signed and acknowledged by the incorporators for the purpose of forming a non-profit corporation under the provisions of Act No. 327 of the Public Acts of 1931, as amended, as follows:

ARTICLE I.

The name of the corporation is Latvian Foundation FUND

The purpose or purposes for which the corporation is formed are as follows:

To promote the preservation of Latvian culture, to conduct educational undertakings calculated to preserve and perpetuate Latvian culture and ethnic traditions, to sponsor research on Latvian history, to aid in the publication, preparation, and promulgation of Latvian literary works. This corporation is not organized for the pecuniary profit of its directors, officers, or members; no part of its net income shall inure to the benefit of any officer, director, or member; and any balance or money or assets remaining after the full payment of corporate obligations of all and any kinds shall be devoted solely to charitable, educational, and benevolent purposes of the corporation.
